  - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs.160,000,000.00 Without VAT.**
  - Minimum Work experience of similar size and nature: Participation as Prime contractor, management contractor, or subcontractor, in **at least One Interior Contract of Bank/ Corporate Building within the last ten (10) years**, with a value of at least **NRs 80,900,000.00 Without VAT** that have been successfully or are substantially completed and that are similar to the proposed works. The similarity shall be based on the physical size, complexity, methods, technology or other characteristics as described in Section VI, Works Requirements.
2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope.
