

# INVITATION FOR BIDS

## Invitation for Bids for the Construction of Additional Finishing & MEP works of Muktinath Bikas Bank Corporate Building

1. Muktinath Bikas Bank Limited has allocated funds towards the cost of **Construction of Additional Finishing & MEP works of Muktinath Bikas Bank Corporate Building** and intends to apply part of the funds to cover eligible payments under the Contract for **Construction of Additional Finishing & MEP works of Muktinath Bikas Bank Corporate Building**. Bidding is open to all eligible Nepalese Bidders. J/V is not allowed.
2. Muktinath Bikas Bank Limited invites sealed bids from eligible bidders for the **Construction of Additional Finishing & MEP works of Muktinath Bikas Bank Corporate Building** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs 90,600,000.00 (Excluding VAT)**
  - **Minimum Work experience of similar size and nature:** Finishing and MEP works of One Building Contract having double basement within the last ten (10) years, with a value of at least **NRs 36,200,000.00 (Excluding VAT)** that have been completed that are similar to the proposed works. The similarity shall be based on the physical size, complexity, methods, technology or other characteristics as described in Section VI, Works Requirements.
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

  6. Sealed bids must be submitted to the office of Muktinath Bikas Bank Limited, General Service Department, Hattisar, Kathmandu, before **Office Hour** on 15<sup>th</sup> day of publication of the notice. Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend at 2.00PM at **16<sup>th</sup> day of bid publication notice** at the office of Muktinath Bikas Bank, Hattisar, Kathmandu. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security amount of **Nrs. 1,500,000.00**, or **5% of BID amount** (Before VAT) whichever is higher, which shall be valid for 90 days beyond the validity period of the bid.
  8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
  9. Non submission of the required documents and non-compliance of mandatory requirements as mentioned above may lead to the disqualification of the proposals.
  10. The Employer reserves the right to accept or reject, completely or partially any or all the bids without assigning any reasons, whatsoever.
